Waiver & Release of Liability

Disclosure

Lake Aurora Christian Camp's Initiative Course programs involve a variety of activities that often include warm-ups, games, and group initiative scenarios. The level of participation in a Paintball program activity is at all times completely up to the individual's choice. **LACC** requires safety equipment at all times and inspection and calibration of both house and outside equipment.

Release of Liability

In consideration of Lake Aurora's Summer Program for 7th -12th graders to furnish services and/or equipment to enable me to participate in paintball games, I agree as follows:

I fully understand and acknowledge that; (a) risks and dangers exist in my use of Paintball equipment and my participation in Paintball activities; (b) my participation in such activities and/or use of such equipment may result in my injury or illness that could cause serious disability and/or death; (c) these risks and dangers may be caused by the negligence of the owners, employees, officers or agents of **LACC**; the negligence of the participants, the negligence of others, accidents, the forces of nature or other cause. These risks and dangers may arise from foreseeable or unforeseeable causes; and (d) by my participation in these activities and /or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers, employees of **LACC**, or by any other person.

I affirm that my health is good, and that I am not under a physician's care for any undisclosed condition that bears upon my fitness to participate in the Paintball Course activities. I have provided my health/accident insurance coverage information and my health/medical information on my summer registration form.

I, on behalf of myself, my personal representatives and my heirs, hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify **LACC** and it's owners, agents, officers and employees from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my use of Paintball equipment or my participation in Paintball activities. I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or conduct by the owners, Board of Trustees, or employees of **LACC**. This waiver is good through **10/10/2017**.

I HAVE READ THE ABOVE WAIVER AND RELEASE AND BY SIGNING IT AGREE IT IS MY INTENTION TO EXEMPT AND RELIEVE LACC FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH CAUSE BY NEGLIGENCE OR ANY OTHER CAUSE.
